

Page 6; Section 6: Line 72 – 74 be deleted and the following language or the functional equivalent be substituted in lieu thereof: “Appointees shall regularly attend meetings and shall not be allowed to vote by phone except in the case of an emergency special meeting, the notice of which is given pursuant to Section 1-225(d) of the General Statutes.”

Page 9; Section 6, line 101: Insert the words. “if available” after the phrase “on the town web page....”

Page 10, Section 11: Delete “thirty (30) days” and substitute, in lieu thereof: “sixty (60) days....”

Page 30, Section 7, line 162: Add the words “if available” after the phrase “on the town web page....”

Page 11; Section 11: Lines 204-206 be deleted and the following language or the functional equivalent be substituted in lieu thereof: “Appointees shall regularly attend meetings and shall not be allowed to vote by phone except in the case of an emergency special meeting, the notice of which is given pursuant to Section 1-225(d) of the General Statutes.”

Page 11, Section 12: Line 208 be deleted and the following substituted in lieu thereof: “...commission, including those appointed by the mayor, as follows:”

Page 11; Section 12: Line 210 be deleted and the following be substituted in lieu thereof: “ ... of the Board or Commission, whether a regular or special....”

Page 11; Section 12: Line 213 be deleted and the following be substituted in lieu thereof: “meetings of the board or commission, whether regular or ...”

Page 11, Section 12: The following, of the functional equivalent be added as subsection (3): “For just cause, as determined by a majority vote of the Town Council, after notice and an opportunity to be heard is given to the appointed official.”

Page 11, Section 12: The following, or the functional equivalent, shall be added as subsection (4): “The chairpersons of all boards and commissions shall notify the Town Council of any absenteeism described in sub-paragraphs (1) or (2) above.”

Page 17 Section 5: Changing the format to the same as other sections, including removing “A. Building Inspector” and “B. Board of Appeals.”

Page 8, Section 4, line 47: Delete the word “elected.”

Page 9, Section 7, line 118: Delete the words “...of the elected body....”

Page 10, Section 10, line 196: Delete the word “elected.”

Chapter XV, pages 24-27: Change, where appropriate all references to “Board” so as to refer to “Commission.”

Page 27, Section 13: line 159: Delete the word “elected.”

Page 34, Section 5(B): Delete in line 59, “...shall be the same as in judicial proceedings.” Substitute in lieu, thereof: “...shall generally follow the Administrative Procedures Act.”

Page 35, Section F. Add the following: “The Council may, by ordinance, authorize the Town of Wallingford to enter into reciprocal agreements, with other municipalities, pursuant to which the Wallingford Board of Ethics would handle ethics complaints filed in other towns, and the municipal signatories of the agreements would handle ethics complaints filed in Wallingford. The Town Council shall approve each such agreement”.

Ability of PUC Members to be on other boards, commissions, committees.
