FY 2015 – 2016 BUDGET WORKSHOP

MINUTES

The Special Budget Workshop Meeting of the Wallingford Town Council was called to order at 6:34P.M. It began with a Moment of Silence. The Pledge of Allegiance was said. 3. BUDGET WORKSHOP

PLANNING & ZONING

In attendance: Kacie Costello, Town Planner

Ms. Costello reported that the *Plan of Development* will be completed by the end of this calendar year. Councilor Letourneau asked about Line 58810, Dues and Membership Fees. He asked about Line 57152, Computer and Accessories. Ms. Costello indicated that the copier was not approved.

Ms. Costello explained to Councilor Mansfield that the *Plan of Development* has to be updated every ten (10) years and that Wallingford's plan expired on April 22, 2015. She said that legislation has been put in place to get a waiver from OPM to extend. Once the plan is completed, the Town will ask for a waiver since it did not meet the deadline of filing a new plan.

Councilor Letourneau asked if in the Planning and Zoning Office had internet access. Ms. Costello said that they did not but that as soon as their new computer is installed, they will be getting limited internet access in about one month. At the present time, Ms. Costello uses computers in Program Planning to meet her department's email needs.
